With news of the revised draft of the 'Pharmacovigilance Guidelines for Marketing Authorization Holders of Pharmaceutical Products in India' being close to finalization by the Indian regulatory authorities, understanding pharmacovigilance is now a compelling need for all the stakeholders in India.

At this ripe moment, the task of integrating and streamlining the opinions and expectations of all stakeholders of Indian pharmacovigilance assumes significant relevance. The Indian Pharmacovigilance Day 2017 conference is all set to achieve this formidable goal with immense focus and dedication. During the conference, expert speakers from the industry, health authorities, research bodies, academia and healthcare delivery centres will share their perspectives on the multifaceted outlook of the discipline of pharmacovigilance in

India and deliberate on the challenges they expect to face in 2017, covering several aspects of pharmacovigilance that India is involved in."

Mr Enrico Pedroni, Managing Director of EasyB srl based in Bergamo, Italy expressed his happiness in organizing their second event in India. "It was a pleasant experience for us to work with Dr J Vijay Venkatraman when he was the Chair of our UK and Indian Pharmacovigilance Day conferences so far.
